Dear Member of Mahogany Hills Homeowners Association:

The 2025 Annual Membership Meeting and Election will be held on Thursday, October 9, 2025. There are two (2) forms included in this notice. The deadline to submit a nomination to the Board is no later than 5:00 p.m. on Monday, July 7, 2025.

1. Three-Year Quorum Only Proxy
2. Declaration of Candidacy

The first form is the Three-Year Quorum Only Proxy, it is the most important and requires your attention. The proxy allows for the Annual Membership Meeting and Election to be held whether or not you are able to either attend or send in a ballot. The proxy **does not** take away your ability to vote and **does not** give anyone the right to vote for you. It is only used to help meet quorum requirements to hold the meeting. Please return your completed Three-Year Quorum Only Proxy via mail or email, as listed on the form.

If you are interested in serving on the Board of Directors, please ensure you meet the Candidate Qualifications listed on the form. If you meet all qualifications, complete the Declaration of Candidacy Form, and return it to Management via mail or email no later than 5:00 p.m. on Monday, July 7, 2025, as listed on the form. We also encourage you to submit a Candidate Statement with no more than 500 words (optional) along with your completed Declaration of Candidacy form.

DECLARATION OF CANDIDACY FOR THE BOARD OF DIRECTORS 2025 ANNUAL MEMBERSHIP MEETING AND ELECTION

The 2025 Annual Membership Meeting and Election will be held on Thursday, October 9, 2025, where three (3) Members will be elected to the Board of Directors for a term of two (2) years and two (2) Directors will be elected to serve the remainder of a two (2) year term expiring October 2026. The Board of Directors requests any Member who is interested in serving on the Mahogany Hills Homeowners Association Board of Directors complete the Declaration of Candidacy Form enclosed, along with a Candidate Statement with no more than 500 words (optional), and return them to the Association by Monday, July 7, 2025, no later than 5:00 p.m.

To have your name placed on the ballot, please ensure you meet the below Candidate Qualifications before returning this form:

- a. Candidates must be a Member of the Association at the time of nomination.
- b. Candidate must be a natural person, not a corporation or a trust. A corporation or trust may be represented by the appointment of a natural person.
- c. Candidates for election to the Board shall be disqualified for any of the following reasons:
 - i. If the candidate discloses or the Association becomes aware of a past criminal conviction that either prevents the purchase of fidelity bond coverage or terminates the existing fidelity bond coverage should the person be elected.
 - ii. If the candidate would be serving on the Board at the same time as someone else on title for their separate interest and the other person is properly nominated or an incumbent director.
 - iii. For failing to pay regular and special assessments. For the purposes of this ground of possible disqualification, regular and special assessments do not include fines, fines renamed as assessments, collection charges, late charges or costs levied by a third party. A candidate may not be disqualified for failing to pay assessments if they have either paid any disputed regular or special assessment under protest or have entered into a payment plan. In addition, a candidate may not be disqualified for failing to pay assessments if that candidate has not been provided opportunity to engage in the Association's Internal Dispute Resolution process.
